## Data Protection - Privacy Policy

This policy applies between you, the User of this Website and Machin Lane Partnership trading as Machin Lane, the owner and provider of this website. This policy applies to our use of any and all Data collected by us in relation to your use of the Website.

We respect your privacy and want to be clear about how we handle information about you. We cover:

- What information we collect about you
- How we use the information
- How we share the information
- Sharing information with third parties
- Cookies
- Your rights
- Changes to this policy

## What information we may collect about you?

We may collect personal data about you during the course of our work. That may include things like: your name, address, telephone number, email address, your wishes and criteria in any transaction you are considering, financial information, for example about your income and capital resources once you enter into a transaction.

Usually we will have received this directly from you. However, we may also receive personal data about you from others, such as from the other party to a transaction you are engaged in or from other agents. Family members also sometimes provide information about each other.

## How will we use the information?

Our use of such personal data is subject to data protection law.

We mainly use your personal data to provide you with information or services you have requested. We may also use it for any other purpose for which you give your consent. For example, we may send you additional information about the firm or its services, if you have consented to us doing so.

We may also use it for other normal purposes connected with our work. For example, we will use your information to update our own business records, complete statutory returns, and otherwise comply with our regulatory obligations. We may also use your information to send statements, invoices and payment reminders to you, your solicitors who you use for conveyancing or to collect payments from you.

## Will we share information about you with anyone?

We will never sell your personal data to anyone, and we take precautions to keep it secure. However should Machin Lane be sold your information would be transferred as part of the sale.

## Third Parties

It will sometimes be a normal and necessary part of our work to pass on information to third parties. For example:

- We may pass on relevant information about you to solicitors to help them proceed with a transaction in which you are involved.
- We need to use information about you to carry out Anti Money Laundering checks that are required by law.

In addition, our practice may be audited or checked by third parties such as our accountants, which may enable them to see some information about you. Such third parties are required to maintain confidentiality in relation to your information.

## Cookies

Machin Lane Partnership use cookies to enable your use of our site, help us to provide you with the best level of service and to monitor traffic, store and track information about your use of Machin Lane. "Cookies" are small pieces of information sent by a web server to a web browser, which enables the server to collect information from the browser. You can erase or block cookies from your computer. ## Your rights

You have a right of access, under data protection law, to the personal data that we hold about you. We seek to keep that personal data correct and up to date.
